Invitation to Bid

RE-PIPING OF THE EXISTING WATER SUPPLY DISTRIBUTION SYSTEM AT MANDARIN HOMES, BRGY. F. DE CASTRO, GMA, CAVITE (SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING)

- 1. The *General Mariano Alvarez Water District (GMAWD)*, through the GMAWD General fund, intends to apply the sum of *Eight Million Five hundred Thousand Pesos and 00/100 (Php 8,500,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Re-piping of the Existing Water Supply Distribution System at Mandarin Homes, Brgy. F. de Castro (Supply, Delivery, Installation, Testing and Commissioning) Contract 02-2018.* Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The General Mariano Alvarez Water District (GMAWD), now invites bids for Re-piping of the Existing Water Supply Distribution System at Mandarin Homes, Brgy. F. de Castro (Supply and Delivery of uPVC Pipes, Mechanical Fittings and Service Connection Tapping Fittings; Cutting & Breaking of Concrete Pavements, Excavation works, Installation of uPVC pipes, Mechanical Fittings & Service Connections; Sand Bedding and Backfilling works; Testing & Commissioning; Restoration and Clearing works). Completion of the Works is required within one hundred twenty (120) days upon receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from General Mariano Alvarez (GMA) Water District and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be purchased by interested from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Ten Thousand Pesos (Php 10,000.00)*.
- 6. GMAWD intends to limit the Pre-Bid Conference to Bidders *who have purchased* the Bidding Documents.
 - The *GMA Water District* will hold a Pre-Bid Conference on *March 21, 2018, 2:00 pm GMAWD Office Annex Building 3rd Floor. Block 4 Lot 1 Congressional Road, Barangay Poblacion 2, GMA, Cavite. The Pre-bid conference* shall be open only to all interested parties who have purchased the Bidding Documents.
