Invitation to Bid for the Design, Supply of Labor and Materials, Construction, Testing and Commissioning of One (1) Unit – 500 Cubic meter Glass Fused to Steel Tank with Glass Fused to Steel Tank Floors at GMAWD lot, Riverview Place Subdivision West, Barangay Delas Alas, GMA, Cavite

1. The *General Mariano Alvarez Water District (GMAWD)*, through the *GMAWD General Fund 2023*, intends to apply the sum of *Nine Million Two Hundred Thousand Pesos (₱ 9,200,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Design, Supply of Labor and Materials, Construction, Testing and Commissioning of One (1) Unit – 500 Cubic meter Glass Fused to Steel tank with Glass Fused to Steel tank floors / Contract No. 03 - 2023*. Bids received in excess of the ABC shall be automatically rejected on bid opening.
2. The *General Mariano Alvarez Water District (GMAWD)* now invites bids for the *Design, Supply of Labor and Materials, Construction, Testing and Commissioning of One (1) Unit – 500 Cubic meter Glass Fused to Steel tank with Glass Fused to Steel tank floors. Includes provision of expertise, design, labor, materials, tools & equipment, machinery, transportation, storage, disposals, sampling & testing needs and the construction safety and health program. Supply of plates and sheets, sealants, devices necessary to install and secure reinforcement, cement & aggregates, magnetic water level indicator and other means necessary to complete all Works required to complete the Contract*. Completion of the Works is required within *One hundred twenty (120) Calendar Days from the issuance of the Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *GMAWD* and acquire the Bidding Documents at the address given below **during Monday – Friday, from 8:00 AM to 5:00 PM except Holidays**.
5. A complete set of Bidding Documents is posted in the PhilGEPS from October 24, 2023 and should be acquired by prospective bidders during scheduled issuance from *GMAWD* by interested bidders on **October 24, 2023 to November 10, 2023 Monday to Friday**

from 8:00 AM to 5:00 PM from given address below *and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php 10,000.00)**.*

6. The *GMAWD* will hold a Pre-Bid Conference on **November 10, 2023 at 2:00 PM** at *Block 4 Lot 1, Congressional Road, Barangay Poblacion 2, GMA, Cavite* for *Pre-Bid Conference, which shall be open to prospective bidders complying to the scheduled submission of letter of intent and acquisition of the bidding documents on issuance.*
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **November 24, 2023 at 1:00 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **November 24, 2023 at 2:00 PM** at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *GMA Water District* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
11. *A "TWO ENVELOPE" system shall be adopted in the tendering. The first bid envelope shall contain the qualification & eligibility documents and technical components. The second envelope will contain the financial component.*
