INVITATION TO BID FOR THE

PROCUREMENT OF GMA WATER DISTRICT'S SOFTWARE UPDATE AND MAINTENANCE OF A CLOUD HOSTED SUBSCRIPTION BASED GEOGRAPHIC INFORMATION SYSTEM (GIS)

- 1. The *General Mariano Alvarez Water District (GMAWD)*, through the GMAWD General Fund, intends to apply the sum of *THREE MILLION EIGHT HUNDRED THOUSAND PESOS (Php 3,800,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *PROCUREMENT OF GMA WATER DISTRICT'S SOFTWARE UPDATE AND MAINTENANCE OF A CLOUD HOSTED SUBSCRIPTION BASED GEOGRAPHIC INFORMATION SYSTEM (GIS)* / Contract No. 01 2024. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *GMA Water District* now invites bids for Software Update and Maintenance of a Cloud-Based GIS. Installation of the System is required within ninety (90) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from **GMAWD a**nd inspect the Bidding Documents at the address given below during Monday – Friday, from **8:00 AM to 5:00 PM except Holidays**.

- 5. A complete set of Bidding Documents is posted in the PhilGEPS from April 30, 2024 and should be acquired by prospective bidders during scheduled issuance from GMAWD by interested bidders on May 13-24, 2024, Monday to Friday from 8:00 AM to 5:00 PM from given address below and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00).
- 6. The *GMAWD* will hold a Pre-Bid Conference on **May 24, 2024 at 2:00 PM** at *Block 4 Lot 1, Congressional Road, Barangay Poblacion 2, GMA, Cavite for Pre-Bid Conference, which shall be open to prospective bidders complying to the scheduled submission of letter of intent and acquisition of the bidding documents on issuance.*
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **June 7**, 2024 at 1:00 PM. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on **June 7**, **2024 at 2:00 PM** at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *GMA Water District* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
- 11. *A "TWO ENVELOPE"* system shall be adopted in the tendering. The *first bid envelope shall* contain the qualification & eligibility documents and technical components. The second envelope will contain the financial component.
